Shared Parenting Workshop Agreement

1. This agreement must be signed in order to participate in the workshop.
2. The workshop, by its nature, will include open discussions intended to illustrate solutions to problems in the post separation parenting relationship. The content of those discussions are confidential and not intended to be used for anything other than educational purposes. The only exceptions to the confidentiality of these workshops are those required by Alaska Statute and Regulation (Sec. 08.86.200. Confidentiality of communication and AS 47.17.020).
3. Participants in the workshop likewise agree to maintain the confidentiality of all members of the workshop. They shall not disclose to others nor shall they offer testimony about what others said in the workshop.
4. Workshop materials such as the parenting manual or handouts are the intellectual property of Allen Levy MS LPA. They may not be copied, distributed, sold or reproduced in any manner without the express permission of Allen Levy MS LPA.
5. The workshop will consist of 2 sessions lasting 4 hours each. Participants are encouraged to ask questions to improve their understanding of course materials. In order to assure that the entire course curriculum will be covered in the time available, specific questions about participants' particular cases or situations will not be answered.
6. The cost of the workshop is:
 - a. \$50.00 for registration and class workshop materials. Registration fee is nonrefundable.
 - b. \$680.00 for the workshop. The workshop is billable to insurance. A sliding fee scale is available for those without insurance coverage. Payment is due at the start of each session unless other arrangements have been made.
7. Missed workshops and late attendance: No refunds will be given for missed or late workshop sessions.
8. Workshop participants may request individual consultations with the workshop leader. Individual consultations cost \$230.00 per clinical hour for one person or \$235.00 per clinical hour for two or more participants in the consultation. Confidentiality as stated above applies to individual consultations.

9. Workshop participants are invited to attend follow up group sessions that occur monthly (or more often at the request of the group participants) for problem solving and help in applying the concepts taught in the workshop. Follow-up groups cost \$170.00 per session and can be billed to insurance. Participants may also request individual consultations.

10. Divorce and custody litigation can be extremely stressful. Workshop participants agree to conduct themselves in a mature and respectful manner with the other participants and the workshop leader. Disruptive and/or disrespectful behaviors will be cause for removal from the workshop. Registration and other fees will not be refunded.
